Yesterday it is Eric Zemmour, sentenced for the second time for incitement to racial hatred last September, who was invited to react on the acts of Bayonne on the channel Cnews at a prime time." declared Mjid Guerrab, MP, LREM-----On May 9, 2019, M'jid El Guerrab, deputy representative of the French Maghreb and West Africa, questioned Christopher CASTANER, Minister of the Interior, to know if we could fear an anti-Muslim attack in France on the model of the Christchurch bombing in New Zealand. The Minister confirmed at the time that this fear was justified and that three attacks of this type had been foiled by the State services in the last 2 years. Yesterday, what was predictable happened and two people were close to death because of their religion. Faced with the reality of this threat, it is up to the State to take all necessary measures to ensure that such an act does not happen again and to protect our compatriots of Muslim faith.
